

After reviewing the results of the meeting of the Policy Review Committee held on Wednesday, March 9, 1977, to discuss U.S. policy to Cuba, I have concluded that we should attempt to achieve normalization of our relations with Cuba.

To this end, we should begin direct and confidential talks in a measured and careful fashion with representatives of the Government of Cuba. Our objective is to set in motion a process which will lead to the roestablishment of diplomatic relations between the United States and Cuba and which will advance the interests of the United States with respect to:

- -- Combating terrorism;
- -- Human rights;
- -- Cuba's foreign intervention;
- -- Compensation for American expropriated property; and
- Reduction of the Cuban relationship (political and military) with the Soviet Union.


