

CHAPTER IV

CONCLUSION

In this chapter will describe some of the conclusions that related with implementation of government policies in dealing under-age marriage in East Lombok. In this chapter also will explained some of the recommendations to the Government of East Lombok, what things should be done by the Government to dealing the issues of under-age marriage in East Lombok, beside that some of these recommendations provided a reference for the performance of all parties concerned to dealing under-age marriage in East Lombok.

A. Conclusion

1. The result of government policies in dealing under-age marriage is now lots of stakeholders and citizen who don't know about the existence of this local regulation and what the purposes of this local regulation. Lack of understanding because the Province Government has less socialization to the stakeholders, regional officials, moreover to the citizens. The point is there is no local regulation information socialization.
2. Stakeholders agree that under-age marriage is an acute problem in East Lombok that have some bad influences to the social welfare and children rights in East Lombok. Under-age

marriage occurred because some factors, such as culture, religion, economic, environment, poverty, dropouts and other. These factors cause under-age marriage happen in East Lombok that in dealing it difficult.

3. In order to support the implementation of Local Regulation Number 8 of 2015, the stakeholders related with under-age marriage have some programs. The programs in generally are make cooperation with the stakeholders that related with women protection and children protection. Beside that the program is give socialization to sub-districts and villages. The program also is make a mediation with the family of under-age marriage actor, and the program focused on some organization divided in some sub-districts and villages to dealing under-age marriage, where the example here are Masbagik Sub-districts and MontongGading Sub-districts.
4. In the practicing some programs to dealing under-age marriage, there are some obstacles, such as less budgeting, less human resources, less socialization, under-age marriage data is less because the society reluctant to report it, the law clashed by the religion and culture and the most important obstacle here is Law Number 1 of 1974 about Marriage is not sync with Local Regulation Number 8 of 2015. But to dealing these obstacle, all

of stakeholders always keep trying and keep seeking dealing the under-age marriage.

B. Recommendation

1. The first recommendation for the Indonesian Government is to make sure about the connection among Law Number 1974 and other Laws or Local Regulation that related with Women Protection and Children Rights. Government should make new strong Law and immediately remove Law Number 1974, because with the termination, then the expected the minimum age of marriage is offered up.
2. For the Provincial Government of West Nusa Tenggara Province that minding women protection and children protection, the government should make more socialization to the officials in all regencies and citizen of West Nusa Tenggara. The point is information socialization should equal.
3. The last recommendation for the stakeholders and citizen in East Lombok that they should make cooperation to dealing under-age marriage through make areport if under-age marriage happen in around them.
