

## **CHAPTER V CONCLUSION**

As we know that LGBT in Indonesia has been around since the 1960s. then they spread until now. The LGBT movement (Lesbian, Gay, Bisexual, and Transgender) in Indonesia are still the pros and cons to the society and also the government. The existence of LGBT is considered not in line with the values of culture and religion that developed in Indonesia because politically, the Indonesia embraces the democratic system, but Indonesia still prioritizes religion as the foundation of the state, it is contained in the first chapter of Pancasila. Their sexual orientation is perceived as a bad impact of globalization that legalizes these people and is feared will affect other communities, even LGBT people tend to be discriminated against by the public. In many point of view that LGBT movement can not be legalized in Indonesia, such as beside of Indonesia embrace of Pancasila and also in National Law on Marriage number 1 of 1974 article 1 states that marriage is an inner bond between a man and a woman as husband and wife with the aim of forming a happy and eternal family (household) based on God. It means Indonesia can not be legalized same-sex marriage because the mentioned in the National Law on Marriage can be done only between a man and a woman and certainly this is strongly opposed by all religions. It is still strongly related to the very strong religion and culture in Indonesia that LGBT movement is a deviant behavior. Behavior is a behavior that is not in accordance with norms and values that apply in the community. LBGt itself is a behavior that is not in accordance with the values and norms that exist in Indonesia where most of the norms derived from religion, tribe and culture.

However, some LGBT communities are still trying to influence the governments to accept LGBT in Indonesia. LGBT communicate and campaigns its programs through various facilities and services, including the following:

- c. Network/Community Method
- d. Business Method
