Shinzo Abe repeatedly made statements that the Japanese military will be in normal state sooner or later, however, many of the Japanese people including the some elite believes that Japan is better off without having any kind of normal military, and prefer more on increasing economical standards in order for Japan to be an economic giant.

In the times of war and conflict, the Japanese empire had made an agreement with the United States of America called Treaty of Mutual Cooperation and Security. The treaty state that with the Japanese forces absent, the United States forces will protect them in their stead. With sufficient military power protecting another country, the US military expenditure soar, thus, the US made further agreements with Japan in order to split the expenditure of the US military in half.
