Q: What is involved in planning the construction of Purworejo certified already mentioned

about planning infrastructure development and infrastructure?

A: Yes, already mentioned.

Q: Infrastructure development and infrastructure existing in any development planning of

Purworejo?

A: There has been a lot of development done in Purworejo regency in accordance with the

planning although it is not yet 100%. Such as the construction of makeover Purworejo and

Kutoarjo faces, the construction of the road in the southern circumference of Purworejo,

ground breaking the construction of the Bener dam, also the development of Baledono

Market in Purworejo.

Q: What is infrastructure development and infrastructure that already passed related to the

new airport development issues in Kulon Progo?

A: Indirectly, the development connected with the new airport. Like make over the faces of Purworejo and Kutoarjo, the maintenance of the monument welcome to Purwodadi and Bagelen sub-districts as the border with DIY, and now the ground breaking of the dam construction in Bener sub-district. Construction of the dam is also one of the goals is to develop tourism Purworejo. But the main priority is to fix the infrastructure and infrastructure of the district itself, such as the construction of the reservoir will be used as irrigation and also the provision of raw water. In addition, the development is done to achieve the target of the RPJMD that has been ratified.

directly adjacent to DIY.
