

**CHAPTER II**  
**GENERAL DESCRIPTION OF THE OFFICE OF WOMEN'S**  
**EMPOWERMENT AND CHILD PROTECTION IN THE**  
**CITY OF MATARAM**

**A. History**

Initially the Department of Women's Empowerment and Child Protection of Mataram City joined family planning. The establishment of women's empowerment and family planning (PPKB) establishment in 2008 joined PPKB and PPPA in one field, in this field there are women and children protection under the PPPA monitoring. In these fields belong to family planning, after running from 2008-2016 and at the beginning of 2017 the agency for women's empowerment and the protection of the children of the Mataram city became a separate service with type A, while the inauguration of human resources and apparatus at the end of December 2016. In early 2017 we began to make government institutions integrated service centers for women and children (P2TP2A) where this institution that is under the authority of women's empowerment and child protection of the city of Mataram for services to women and children experiencing violence, aside from these services, the institution created a village level children's forum to fulfill the right of participation in these institutions as well as developing to fulfill the welfare and protection of children PPPA develops suitable city for children.

This approach to decent cities is used by PPPA institutions to fulfill children's rights and includes protection rights and includes protection rights especially that is what P2TP2A does to serve several functions of P2TP2A, there is function of information and complaints, health services, social legal service and pre-integration services (empowerment) for both women and children. With the development of several programs carried out from 2017-2018 PPPA has progressed a lot in the development of child-worthy cities which have the title of a decent city for advanced children. Then the children's forum also received the title of national level child forum with the best coaching. When compared to women's empowerment, children with family planning are far away from the rapid development of service to the community, especially women and children programs that are run very well and the budget is far more that imagined with the family planning budget.

Community service is very much like empowerment. Empowerment here, for example, trains victims of violence to get an approach from the family and increase the victim's economy. After we gave training then we gave the tools according to what was trained earlier.
