## CHAPTER V CONCLUSION

Based on the results of the discussion of the role of UNICEF in realizing the rights of persons with disabilities in Indonesia in 2016-2017, the authors conclude that UNICEF is an International Organization that has a function as an institution that distributes humanitarian assistance especially to children. UNICEF provides assistance to children with disabilities in Indonesia.

The discrimination against children who have disabilities until now still cannot be eliminated. The discrimination usually arises from one's own family. For various reasons, for example, it is considered as family waste and is useless. These children are often confined and ostracized from school and society rather than being supported. There are even parents who have children with disabilities, and do not registered their children's birth. In the absence of official recognition, they are cut off from social services and legal protection that are essential for their survival.

Then there is also the problem of education in Indonesia, especially in Yogyakarta. There are still problems that must be addressed by the government related to the education services. Some factors that hinder the improvement of the quality of education include limited access to education both due to physical and non-physical factors, such as incomplete school facilities and the uneven distribution of teachers causing a shortage of teachers in schools.

Education is one of the rights possessed by persons with disabilities who are obliged to be protected and implemented by the government. The government programs bringing people with disabilities into regular education are known as inclusive education.

As an addition, there is the phenomenon of violence against children. The case is a violation of child rights divided into nine clusters of cases of violence against children including, Social and Child in Emergency Situations, Family and Alternative Care, Religion and Culture, Civil Rights and Participation, Health and Drug, Education, Pornography and Cyber Crime, Children Faced with Law, and Trafficking and Exploitation.

The economy and the social environment are the main factors causing children to be treated unfairly. Children have their own life goals and rights. This makes UNICEF an international organization that guarantees the welfare of children's rights, seeks to tackle child violence, discrimination, and increase education in Indonesia. UNICEF has established and implemented work programs to achieve its targets, in reducing violence and discrimination against children. This organization in implementing its programs collaborates with Non-Governmental Organizations, as well as Government Institutions, to change attitudes and norms.

Until the end of this study in 2017, UNICEF could be said to be successful in carrying out its mission to tackle the problem of child violence in Indonesia. In fact the implementation of the work program program established by UNICEF can be carried out properly and correctly. This is due to the support of the government and the people of Indonesia. The running of the basic functions of International Organizations, can help to reduce the cases of child rights violations and the cases of discrimination.

After all, Children with disabilities have the same position, rights, obligations and roles as Indonesian citizens. Persons with disabilities are state assets in the field of Human Resources that have advantages and disadvantages as other human beings. The potential of persons with disabilities can be developed in accordance with the talents of being born.
