CHAPTER III

RESEARCH METHOD

A. Type of Research

The type of the research is Normative legal research which is a research based on the documentary or normative fact, focusing on reading and analysis of the primary and secondary materials.⁶¹ Here the researcher collected the data from library in order to find the regulation and theory related to the object of research. In order to find another information needed, the researcher collected the data from articles, news, and other supporting media.

B. Type of Data

The data used in this research is secondary data, the secondary data consist of primary, secondary, and tertiary legal material. Primary legal material is the legal material which is authoritative in nature. It means the material has an authoritativeness. The secondary legal material refers to all publications related to the law except for official document.⁶² These legal materials consist of the responsibility of the carrier against loss of passengers⁶³;
