ABSTRACTION

After several decades the nation-state was unable to settle several issues and problems between states through diplomatic negotiation. The International Organization began to appear, changing the nation-state as a primary actor in political affairs. The International Court of Justice (ICJ), a principal organ of the United Nations (UN) as the biggest International Organization, has been believed as the best adjudication way in disputes settlement between states, such as territorial dispute. Hence, in 2003 Malaysia and Singapore agreed to submit their territorial dispute over sovereignty of Pedra Branca/*Pulau Batu Puteh* in the entrance of Straits of Singapore and two other maritime features Middle Rock and South Ledge to the ICJ. Furthermore, the dispute was resolved after the final decision of the Court on May, 2008. In line with the title, this undergraduate thesis tried to explain about The Adjudication Process of International Court of Justice on Pedra Branca/*Pulau Batu Puteh* dispute between Malaysia and Singapore.
